

#### **Proxy Voting**

If you are unable to attend this meeting, you can still vote by using a proxy\* form. Proxy forms will be available on the reverse side of your registration card that will

appear on the cover wrap of the October issue of Carolina Country magazine. Any member may vote his or her vote and one (1) proxy vote on behalf of one residential member and (1) one additional proxy vote on behalf of members such as churches, businesses, organizations or similar groups, provided the member is so designated as the authorized representative of the organization. Moreover, all proxies must be valid as determined by the Credentials and Election Committee.

To assign your proxy vote for another member, you must fill out the information on the back of the registration card, including the name of the person you give your proxy. Please date and sign your name to the proxy and have someone witness your signature.

# **Electrical Hazards on the Farm**

It's that time of year for many farmers to begin gathering their fall crops and Four County EMC wants to remind you to be safe around power lines. Those who live on a farm know that not only is it hard work, but it can be dangerous, too. Each year, farmers are electrocuted when large farm machinery comes into contact with overhead power lines.

Often, the situation occurs because a newer, bigger piece of equipment no longer clears a line the way a smaller one did. In addition, shifting soil may also affect whether or not machinery avoids power lines from year to year.

The following tips will help keep everyone on a farm safe:

- » Look over work areas carefully for overhead power lines and utility poles.
- » Store large equipment properly if near or under power lines. When planning new construction, factor in existing power lines.

Be certain of sufficient overhead power line clearance when working with large machinery, such as this combine.



- » Train all farm workers to keep an eye out for overhead power lines.
- » Make sure you have ample clearance when moving large machinery such as combines, grain augers, pickers, bailers, and front-end loaders. Do this every year as equipment sizes or soil conditions may change.
- » Be extra careful when working around trees and brush; they often make it difficult to see power lines.





### **Ingredients**

- » 6 cups chopped and peeled apples (blueberries, pears and peaches may also be used, minus the cinnamon)
- » ½ cup sugar
- » 1 large crushed can pineapple, drained
- Cinnamon to taste
- » 1 box yellow cake mix
- » 1 cup pecans
- » 1 stick of butter or margarine

Spray 13 x 9 inch glass casserole dish with cooking spray. Mix chopped apples, sugar and cinnamon. Spread evenly on bottom of casserole dish. Dump pineapple evenly over apple mixture. Sprinkle dry cake mix evenly over pineapple. Sprinkle with pecans and

dot with butter. Bake 1 hour or until top is lightly browned and bubbly around the edges. Delicious served warm and topped with vanilla ice cream. Enjoy!
